

# RELEASE/WAIVER OF LIABILITY AND ASSUMPTION OF RISK TO PLAY AIRSOFT

**READ CAREFULLY AND COMPLETE ALL BLANKS** – Use a separate form for each participant.

## SAFETY RULES (must be read to play)

1. Always wear approved airsoft/paintball masks in or near playing field. Not adhering to this rule is cause for immediate dismissal from the game.
2. Never shoot at anyone who is not wearing approved eye protection.
3. Do not shoot at any player showing a neutrality symbol, any non-player, or any judge
4. No player may shoot at any person, object or animal outside the perimeter of the active playing field.
5. Observe all safety rules applicable to firearms when handling airsoft firearms.
6. Only approved airsoft guns will be allowed in the playing arena.
7. Never shoot at another person in anger or with intent to cause harm.
8. No physical confrontation between players is permitted.
9. No dry firing of guns is allowed in any neutral or non-playing area.
10. Do not use an airsoft gun until you have been trained on its use and understand such use.
11. Do not shoot across neutral or staging areas.
12. No refunds will be given if you are asked to leave because of rule violations.

## THE UNDERSIGNED

1. Has asked New Hope Community Church to be allowed to play the airsoft game and acknowledges that the game involves physical exertion and other risks, known and unknown and may result in serious injury or death to the undersigned or others playing or observing the game;
2. The undersigned are aware of the possibility of serious risks of injury or death, including, but not limited to being shot by airsoft, falling, tripping, heat stroke, insect bites & stings, improper use or operation of equipment by the undersigned or other players and others not following the safety rules. The possibility of permanent disability (including blindness or loss of hearing) or death does exist;
3. The undersigned agrees to play the game according to the rules which have been given and to follow directions given by any game referees;
4. The undersigned warrants and acknowledges that his/her physical and mental condition will enable him/her to participate safely in the game;
5. Certifies that he/she is over 18 years old or the parent/legal guardian of the minor participant whose name is on the front of this form;
6. Authorizes use of photos, videos, name, comments, game results, etc. for promotional purposes;
7. Understands that it is his/her responsibility to wear safety headgear provided by New Hope Community Church and any other safety wear deemed necessary by the participant or their parent/legal guardian.

IN CONSIDERATION of being permitted to play airsoft, the undersigned do hereby release, forever discharge, indemnify and agrees to hold New Hope Community Church its directors, officers, employees, members and volunteers harmless from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by the undersigned as a result of playing or observing the playing of airsoft game. The undersigned voluntarily agrees to assume any and all risks associated with airsoft.

I hereby agree to the above release and acknowledge the receipt of the referenced safety rules. I have read and fully understand terms set forth above and I agree to abide by the terms of this RELEASE/WAIVER OF LIABILITY AND ASSUMPTION OF RISK TO PLAY AIRSOFT.
